Policy and Proposals:

There is No current RBS policy

There is an ASC policy that states that any trusted officers and servants elected to RBS may be removed by a vote by 2/3 paper vote confidently. Trusted servants may be dismissed from their position if not compliant to policy as of relapse, missing 2 consecutive RBS meeting w/out notifying facilitator or co-facilitator, not being capable of fulfilling duties of position being filled, misappropriation of NA funds are not able to hold ASC trusted servant position until One yrs of financial amends or resolution agreement has been made. This needs to be put into RBS policy.

Supporting Subcommittee Positions: Each subcommittee is vital to each of our RBS that each candidate or chairperson will be replaced if they are unable to fulfill their service commitment or possibilities for any reason.

CBANA Policy that must be applied is 5 yrs for money handlers.

RBS subcommittee cannot change it in any way.

Consensus was made to change RBS policy. The proposal was approved.
